Equipment Charges:

All users will be charged a minimum equipment use fee according to the following daily equipment charge or per the itemized estimate, whichever is greater.

<u>Theater minimum:</u>	
Commercial:	\$300.00/performance day
Non-Profit/Government/Resident	\$300.00/performance day

<u>Exhibition Hall minimum:</u>	
Commercial:	\$100.00/performance day
Non-Profit/Government/Resident	\$100.00/performance day

Staffing Requirements:

PCPA will **require** the following personnel for use of any interior/external rental space of the building. All time for labor is calculated in whole hour increments.

1. **Technical Director & Event Manager:** \$28.00 per hour (4 hour minimum call, an average event day will utilize 12 hours of Event Supervisor time)
House Technician: \$22.50 per hour (4 hour minimum call).
 The client should understand the Technical Director and House Technician are frequently on call prior to and after client occupancy to attend to light hangs, sound set-ups, orchestra pit level changes, etc. Technical Director and House Technician time is calculated from the time the space is occupied by activity associated with their event until the space is vacated for each move-in, rehearsal, performance and move-out day.
 A. **Stage Hands:** Current rate
 B. **Pit Change Crew:** Current rate
2. **House Manager:** \$19.00 per hour for each performance (approximately a eight hour call per performance). The House Manager will generally arrive two hours prior to curtain time and remain on the premises until approximately one hour following performance. Ushers may be provided on a volunteer or paid basis by PCPA and the number required will be set by PCPA. Generally, client supplied house personnel will not be utilized.
3. **Custodial Support:** (8 hour minimum call) Any custodial costs incurred due to use of building space by the tenant will be billed as follows:
4. **Event Custodians:** \$19.00 per hour/custodians

User Requirements:
